- -I was speaking to a neighbor today when DOWNS was staring at me from his steps.
- -DOWNS made a comment which was inaudible, however I think it was directed at me.
- -I have had problems with DOWNS in the past regarding my political campaign.
- -The police have been called in the past because of the confrontations with DOWNS.
- -Officer Martin advised me to get a restraining order on DOWNS but I don't want to pay the \$300 required to file the paperwork.
- -You don't even have to waste your time talking to DOWNS, I just want this harassment documented.

Observations/Actions cont:

- -I provided HAFNER with several options including information on how to obtain a restraining order.
- -I made contact with DOWNS who was unaware of the complaint.

DOWNS statement:

- -I was talking to my neighbor SCHMIDT when HAFNER drove by in his vehicle.
- -HAFNER parked his vehicle at his residence then walked about a block to where I was talking with SCHMIDT at which point SCHMIDT went inside because he didn't want to get involved.
- -HAFNER got in my face yelling at me so I took out my cell phone stated the date and time and told HAFNER that I was recording him.
- -I did not actually have my video recorder going but did take a photo of him as he was standing in front of me.
- -HAFNER then returned to his residence.

Observations/Actions Cont:

-I attempted to make contact with SCHMIDT via phone for a statement but was unsuccessful.

Disposition:

-Both parties advised to stay away form each other and also how to obtain a restraining order.
