Please find attached a response from the League of Minnesota Cities Insurance Trust to an inquiry from Mayor Longrie concerning the claims experience of the City of Maplewood in comparison to other LMCIT members. You may note that Ann Gergen, Associate Administrator has prepared an illustrative report. Also attached is a report on a ten year total from 1999 to 2008 on the net premiums to claims (excluding auto liability.)

The report also notes our special \$200,000 deductible on employment liability claims. I am hopeful next year to have that special removed in our renewal.

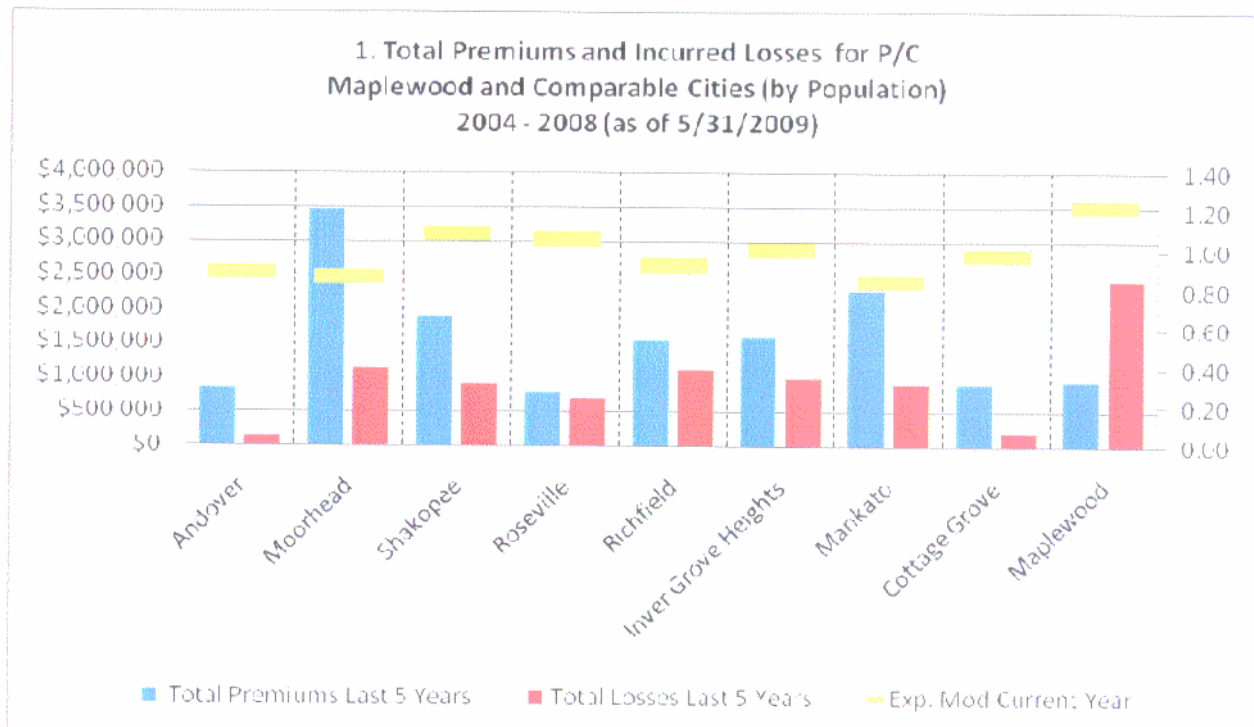
Re: **Maplewood loss data request**

As we discussed last week, LMCIT has been working to collect data for Mayor Longrie's request to compare Maplewood's claims experience to cities of similar size. Mayor Longrie also requested a comparison to the five cities within LMCIT with the highest rate or level of claims and a summary of LMCIT actions for cities with similar claims history to Maplewood.

Not all information was available in formats that correspond directly to the request, so I've tried to put together material I hope will be responsive. I'd certainly welcome any follow-up inquiries after you've had a chance to review the material in this memo.

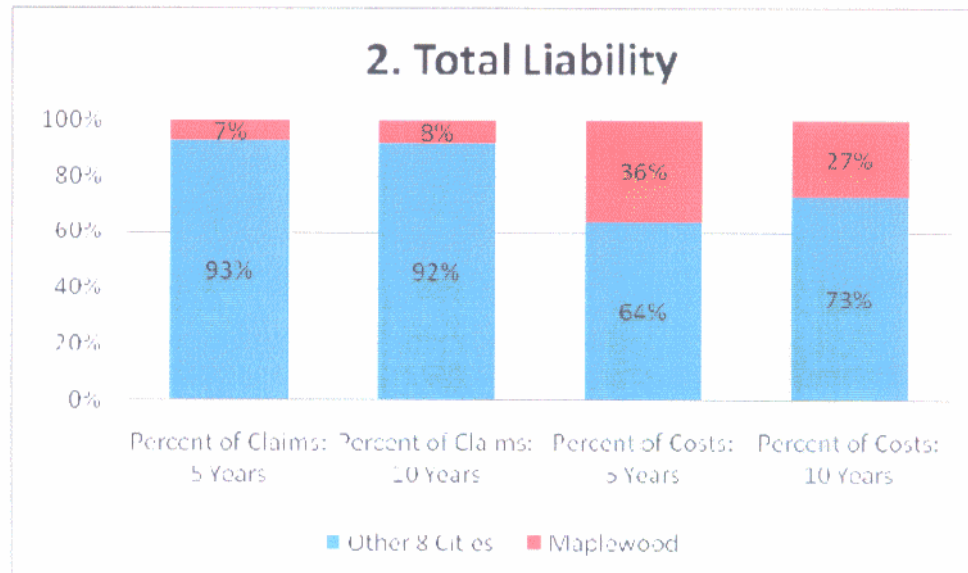
The following set of graphs depicting various measures of loss information may be helpful to start. We identified nine LMCIT member cities, including Maplewood, in the population range of 30,000 – 40,000. Item 1 below depicts total premiums paid, by city, for both property and liability in the last five years as compared to total losses incurred, by city, for property and liability coverage. Also indicated is the current experience modification factor for each city, which is based on three years of city-specific loss history excluding the most recent prior coverage year. A 1.0 experience modification factor (EMF) would represent a LMCIT member city of average risk. EMFs above 1.0 represent those cities with greater losses than the average LMCIT membership; those below 1.0 represent better-than-average loss experience.



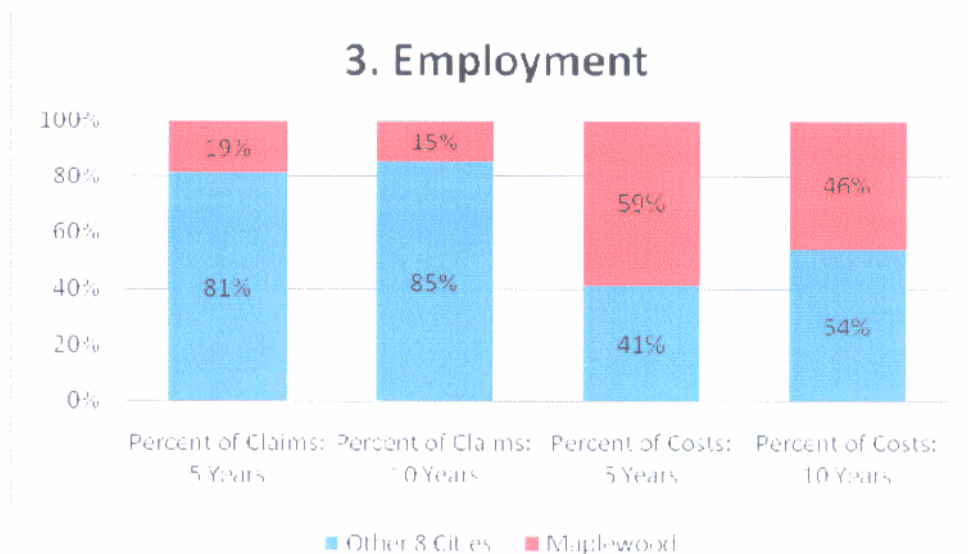
Item 2 presents an overview of Maplewood's overall liability experience, excluding auto liability, compared to the same set of similarly populated cities listed in Item 1. Percent of claims speaks to the number of claims Maplewood has experienced as compared to the universe; percent of costs is the total incurred costs of Maplewood's claims compared to the other eight cities. So, for instance, the five-year comparison indicates Maplewood had 7 percent of the total number of claims for this particular city group and 36 percent of all costs.

For items 2 through 6, the following time periods are reported:

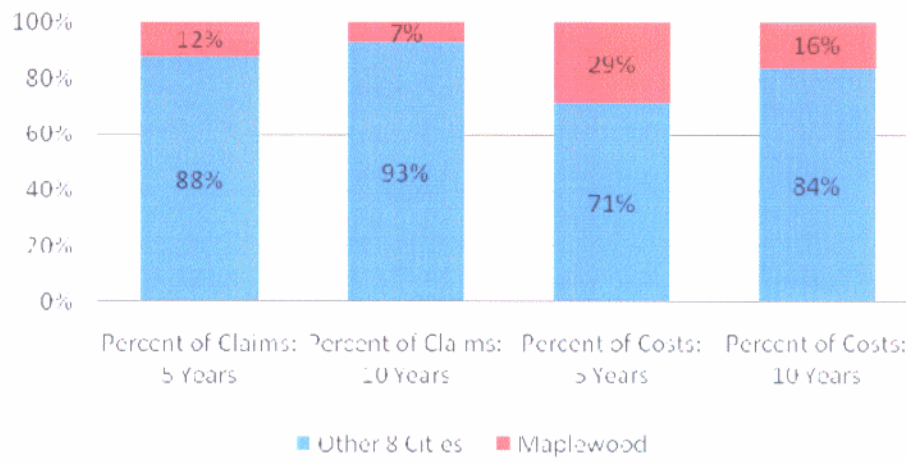
- 5 years is 2004 to 2008 as of 3/31/09
- 10 years is 1999 to 2008 as of 3/31/09.



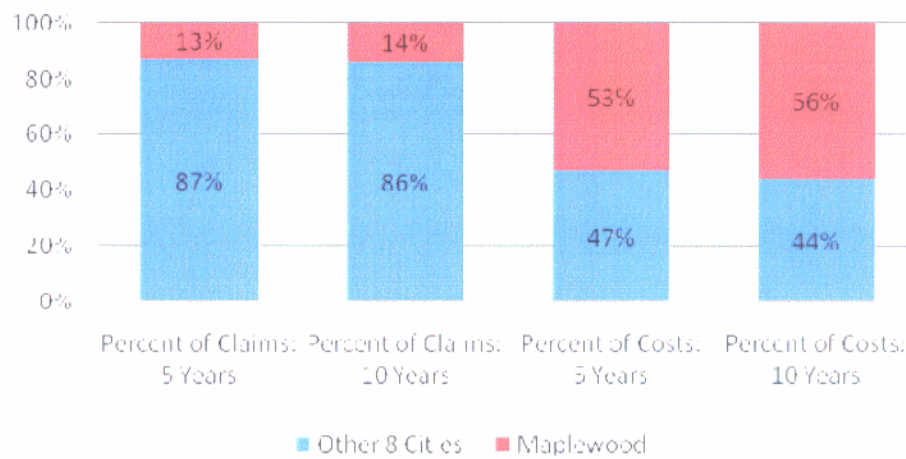
Items 3 through 6 break total liability costs into major categories based on LMCIT liability loss costs. Specifically, these graphs show Maplewood's percent of claims and costs for both five and ten years in the areas of employment liability, land use liability, and police liability. Item 6 includes all other liability, still excluding auto liability, such as administration E&O, streets and sidewalks, sewer backups, etc.

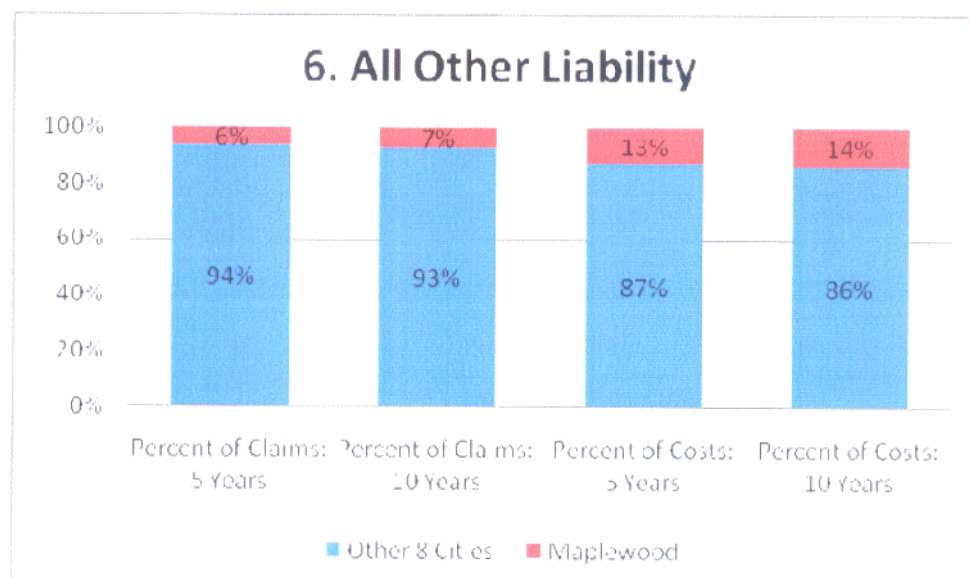


## 4. Land Use

With regards to the request for cities with the highest rate or level of claims, the attached appendix reports liability loss ratios, excluding auto liability, for all member cities. The loss ratio is a measure of gross liability losses (which includes any deductible amounts the city is responsible for) against city premiums shown without any deductible credits applied. In other words, it's a picture of total losses and premiums regardless of the cities' deductible level. This should give the fairest method of comparison for all cities. The report is based on ten years of premium and loss information (1999 – 2008) in sum total.

Maplewood 146<sup>th</sup> on the list of 1190 members for this time period (see line 155). 14 percent (n=164) of LMCIT members for this time period had ten-year loss ratios above 100 percent – in other words, losses in excess of premiums. Of those, most are cities with relatively small amounts of total premium. In smaller cities, one large loss can greatly impact the loss ratio because of the lesser premium.

Cities with greater than 100 percent ten-year loss ratios comparable to Maplewood in terms of premium include Golden Valley, Minnetonka, and Apple Valley. The tables below illustrate the liability loss ratios for just those LMCIT members with more than \$1 million liability premium. Also included is a comparison of the same sort, conducted on a seven-year total loss ratio basis.

Finally, LMCIT has taken special underwriting action to address city risk concerns in three cases in the last several years. There are two or three additional cases of special underwriting action in the almost 30 years of LMCIT history, but those were prior to implementation of current LMCIT underwriting policies.

Situations of special underwriting action are really quite rare and each situation tends to be unique. Underwriting action is generally reserved for those situations where two conditions are met: 1) the city has already generated an unusual amount of loss; and 2) the conditions and problems that gave rise to those losses continue to exist. LMCIT has intentionally retained Board-level discretion to determine the right sort of underwriting action in any given situation, so that LMCIT can address the issue at hand without being overly broad in the limits it places on any member's coverage, and can take appropriate steps to protect other members' assets held by LMCIT.

Below is a summary of special underwriting taken in recent LMCIT history:

**1 – Maplewood.** Maplewood is currently subject to a \$200,000 per occurrence deductible which applies to all employment-related liability claims and all claims involving suits by current or former city officials or employees against the city or against any other current or former city official or employee. LMCIT will next review this special underwriting action in anticipation of Maplewood's July 1, 2010 renewal.

**2 – McGrath.** McGrath is currently subject to the following special terms:

- Municipal liability coverage is limited to claims for bodily injury or property damage. LMCIT does not provide coverage for any claims relating to employment actions, defamation, land use litigation, administrative errors and omissions, and so on.
- Liability coverage specifically excludes claims relating to the sale or maintenance of the community center building.
- LMCIT does not offer the city optional open meeting law defense, bond, or excess liability coverage.

LMCIT will next review this special underwriting action in anticipation of McGrath's April 1, 2010 renewal.

**3 – Greenfield.** Beginning September 1, 2009 the City of Greenfield will be subject to a \$200,000 per occurrence deductible which applies to all employment-related liability claims and all claims involving suits by current or former city officials or employees against the city or against any other current or former city official or employee. The LMCIT Board is also currently considering whether any special termination provisions are a good idea for Greenfield's upcoming renewal, or if a policy term for less than one year makes sense.
