Since mailing my letter of complaint dated Aug. 21, I discovered some more points that I would like to make:

I received an invitation by e-mail to attend their July 28 forum for mayoral candidates. Later, I found out this was not a live show but all taped. I was given a time of "6 to 10 pm". I had no idea when exactly I was supposed to arrive, so I got there when I could. Since then on the TCR web site (thecitizensreporter.com) I am referred to as the candidate who "came late". I only wanted to see who was in the studio, but Frederica Musgrave urged me to join the discussion, so I did.

Since then, the TCR people have made shows called "Evaluating the Candidates" which have aired recently on channel 15. There's one for the mayor candidates and one for the council candidates.

I was not aware that my participation in any Citizens Reporter candidate forums would be scrutinized by the Citizens Reporter again in another series of TV shows. I was not informed that this was their intent. (I wonder if any other candidates were aware of this.)

The "Evaluation" shows give no opportunity for candidates to defend themselves or rebut. Some of the comments made by the shows hosts Waters and Musgrave deserve some rebuttal from candidates.

A few days ago Joe Waters came up to me and said he was sorry about some of the nasty (?) things said about me on some show they did. At the time I didn't know what he was talking about because I didn't know yet about the "Evaluation" show. I have watched this show and didn't find me mentioned anywhere. Is there another show yet to come where I will be a victim of their negative comments? I don't know.

The idea behind these shows was to rate the candidates who responded to the TCR questionnaire. Any candidate who didn't respond to their written questionnaire (I did not respond) was not discussed and received a "zero". Musgrave made up a formula for giving from 0 to 3 points to each candidate as to how they answered the questions. No matter how you look at it, it was the <u>opinion</u> of Musgrave and Waters as to how well the candidate answered their questions. If they didn't like the answer, of course the score would be low. If they <u>felt</u> that the question could have been answered more fully, they would score the answer lower.

30 seconds into the mayor candidates show, Musgrave identifies herself as an "educator" which gives a misleading impression to viewers that perhaps this show is going to present some kind of scientific results.

If Bob Zick's show always has to come with the label "These Are Opinions", then the same should be required of the TCR shows.

There are other things in the mayor's evaluation show that I want to point out:

2 1/2 minutes into the show -- Musgrave said 5 out of 7 candidates answered the questionnaire. This was just a mixup of words because as the show played out, it was clear that 2 candidates had responded, and 5 did not. After this, Musgrave asks co-host Waters about his opinion as to why 5 candidates had not responded. He said, "In my opinion, some of them don't want to be held accountable". At about 14 1/2 minutes into the show, there are more comments along these lines said by Musgrave regarding candidates who didn't respond to questions about transparency in government: "that is saying to me that they're not open and transparent..."

Comments like these are made throughout these two shows, as if to imply that candidates who did not respond to the TCR questionnaire or participate in their tv forums are evil, uncaring, devious candidates (or whatever disparaging names you wish to apply).

If the candidates who didn't participate had a chance for rebuttal, they would probably say the same thing I would: the Citizens Reporter group is just another "special interest" group of a handful of people that have a partisan agenda and they are not in the same category of organizations like the League of Women Voters or the Chamber of Commerce, etc. According to the TCR web site, they are a LLC corporation but what difference does that make? - it's still just a handful of people promoting partisan politics.

9 minutes into the mayor candidates evaluation show, Waters felt the need to make a disclaimer announcement: "She (Diana Longrie) is a contributor to The Citizens Reporter but she's getting no favorable treatment from you (Musgrave) or I."

At about 19 minutes, Musgrave calls candidate Cardinal "lazy" for not submitting the TCR questionnaire. She explained that he sent the Review questionnaire to Musgrave by mistake but that when told about this, he said "just go ahead with what I sent you..." Musgrave said that she wasn't going to bring up Cardinal during their show because they had nothing to discuss, but did, after prompting by Waters, which leads me to believe it was a easy way to "slam" Cardinal. (Musgrave also complained that Cardinal was "text messaging" during the forum)

I also watched the "evaluation" show of the council candidates. At the beginning of the show, Frederica Musgrave made comments that campaign lawn sign rules had been violated in Maplewood, but she didn't give any details at all, or which candidates had been violating the city ordinance. No details at all as to which of the rules had been violated!

2 minutes into the show, Musgrave spends a couple minutes bad mouthing the candidates who did not submit questionnaires to TCR, saying "it was very interesting that the endorsed candidates who received the resolution of support from the DFL...did not submit anything to us..."

42 minutes into the show is the most important point I have to make in this letter:

Musgrave said "I don't know how I'm going to vote — this is a tough election". Then Waters responds, "Mayor Longrie is my candidate for mayor. Robert Martin is my candidate for city council and I'm looking closely at the other (council) ones, and I've eliminated some already, quite obvious."

For the TCR people to claim on their website and on all their tv programs that they are non-partisan and do not endorse candidates, is a misleading insult to the citizens.

TCR should practice full disclosure of some facts before they make negative comments about candidates they don't like:

The leader of this tiny group of 3 or 4 people is Frederica Musgrave, whom I don't believe has disclosed that she lives with one of the city council candidates.

Joe Waters's partisan activities are well known, but hiding behind words like "I'm a reporter", "organization", "non-partisan", etc. is a bit of a stretch.

They have announced that Diana Longrie is a part of this group and so it's assumed that her husband is as well since he and and the other people I have mentioned spend a lot of time at "The Resource Center", which has an office space adjoining Diana Longrie's office.

What I object to is them identifying themselves as an "organization". I have never heard of an organization that has only 2 people out front and maybe 2 or 3 more in the background. This sounds more like a club to me. Instead of presenting "candidate forums" they should promote their favorite candidates only, in a partisan way. The way most candidates have to do it — with flyers, signs, and talking to residents.

Attached are my proposals for making some special policies for candidate forums at the SCC studios.

## PROPOSED NEW POLICIES FOR CANDIDATE FORUMS AT SCC STUDIOS

Aug. 31, 2009

I would like to suggest the following ideas for a **new** set of policies that would be for **candidate forums**:

1. Require that candidate forums be televised *live*.

This will prevent producers/sponsors of candidate forums from shelving a recorded forum and not airing it on the channel(s) in a timely fashion.

- **2. Require** producers/sponsors of candidate forums to provide copies of forums when requested in writing by any candidate or their campaign staff.
- **3. Require** that producers/sponsors of candidate forums use *U. S. postal mail* to invite all candidates to candidate forums, and all forums should be accessible to all filed candidates. E-mails, phone calls, etc. are optional.

There are 3 other policies I would like considered, but the language needed is perhaps more involved and may be better left to the commission, its subcommittees, or legal counsel:

- a) Organizations/producers/sponsors should be required to have a minimum number of people (3 or 4?) responsible for the set-up, televising and later production work of any candidate forum. This will ensure that no one person, or two people "bite off more than they can chew" by committing to too much work (see the attached excuses given me by Frederica Musgrave as to why I had to wait from July 28 to Sept. 1 to see the candidate forum in which I appeared, finally air on channel 15. Also, I was refused a copy of the program by her, citing "I'm too busy" and the like. My response to that is obviously the TCR political schedule has been too taxing for its handful of members, and this is unfair to candidates who participated in their events.
- b) Portions (clips) of candidate forums cannot be used for "commentary" programs such as the "Evaluation" shows that TCR did, unless those shows clearly have the labels "These Are Opinions" and claims such as "we are non-partisan", "we do not endorse candidates", and the like are not allowed to be made. Such programs should be clearly labeled as partisan and opinionated.

c) These and any other policies and rules that are adopted should perhaps come with a penalty if they are not followed: the organization/producer/sponsor not be allowed to produce candidate forums for television using the equipment of the SCC facility. They will still be free to privately produce with private equipment and facilities, any program they wish and channel time will be made available under the usual SCC policies. However, they will not be able to use SCC equipment unless such producers follow all rules and procedures for televising candidate forums. Whether the cable commission would want to extend this policy to include partisan political programming, would be up to the commission.

Dear Commissioners,

I wish to make a formal complaint against a group of people who call themselves "The Citizens Reporter", which held a candidate forum in the SCC studios on July 28. I participated in a portion of this forum but it has not yet aired on SCC channel 15.

This point is the main focus of my complaint:

I understand that on the night of July 28, a **portion** of the forum was aired live however there was another portion that was taped. The portion in which I participated **has not been aired** in replays on channel 15. I have contacted Frederica Musgrave of The Citizens Reporter about this numerous times and have been stonewalled.

A second point of my complaint is that I haven't been able to get a copy of the entire July 28th's taping/live program. Ms. Musgrave has refused to give me a copy. I understand that Bob Zick has also tried to get a copy from her on my behalf and we both have been stonewalled on this as well.

Would the Cable Commission please take the following action:

- 1. The cable commission directs The Citizens Reporter to give copies of the candidate forums they have done to any candidates who participated in those forums, upon their request.
- 2. That the cable commission make some policies regarding candidate forums that would guarantee copies of the forums to participating candidates and timely scheduling of the forums (including replays) on channel 15.

The "Citizen Reporter" group claims to be non-partisan but their delaying the airing of the candidate forum in which I participated (with candidates Cardinal and Longrie) makes me wonder if it isn't a deliberate attempt to put my campaign at a disadvantage.
